****First year additional cost: A share of stock costs \$100 and stock membership requires a one-time \$500 initiation payment.**

As you can see, yearly dues for an individual full membership are \$285 per member less than Associate dues. Your initiation fee of \$500 is paid for in less than two years of dues savings (only one year if a couple membership) and then, at the current rates, you will save \$285 a year. So, if you plan on being a member for more than two years, it will save you money to own a share of stock. Other benefits to stock ownership. Stock members have the choice to pay dues with a payment plan, paying before January 1 and March 1. Also, if you pay in full by January 1, you receive three guest passes and a choice of either a range membership or club storage for \$75 (\$50 savings). In addition, as a Stockholder, you can vote on club issues and be on the Board of Directors so you will have a voice in how your club is run. So, you can see, there are benefits to owning stock and we hope you will consider purchasing a share.
